RVV MUMBAI is an Online Institution Affiliated & Accredited Internationally, Which is running online "Industry Integrated Learning Programme" for working class candidates through e-learning mode with an International Standard Pattern 'At Anytime & At Any Place'.

Rashtriya Vishwa Vidyapeeth, Mumbai is Self Financed Institute which does not comes under UGC, AICTE or DEB. RVV is an Internationally Accrediated Online Institution with ISO / IAO / DAC / CIAC / WABOU / ICDL Approvals. The Courses runned by RVV is an Autonomous Courses designed by RVV Itself and the Certification are Provided by RVV Itself as per vide notification no P.26/4/52 C.C (Ministry of Home Affairs, Government of India dated 20/09/1952).

RVV Provide Certification Programs and Courses Under Online & Distance Mode Via Study Center Based Program. Students Can take admission only through Authorized Admission Resource Center. Otherwise his admission will be found null or void. Study Center has to Give Proper Counseling & Details to the Students i.e. (Affiliations & Validity of Documents & Fees). Any Student taking admission in RVV via Study Center have to fill Fees challan copy & have to submit to their respective Study Centres. Any Study Center if found charging more fees as mentioned by RVV. RVV will not be responsible for this and RVV has the right to cancel that study center at any point of time if found. All Authorized Study Center has to take prior approval of the RVV for any Marketing Activities in the Name of RVV (i.e. Quicker / Just Dial / Sulekha / Mass Mailing & Ads-Promotions) otherwise their Study Center will be Cancelled if Found doing these activities without prior permission.

If Any Students / Learning Centers or Any Concerned Person has any dispute with the RVV. It will be resolved through the Committee appointed by the Rashtriya Vishwa Vidyapeeth, Mumbai under Arbitration Act, 1940. The Decision of the arbitrator shall be final and binding on all parties, Direct Court will not be permissible.
